

Advanced Abuse Investigations:

Domestic violence and child abuse investigations are among the most complex, high risk, and emotionally charged cases law enforcement professionals face. The course also addresses medical and forensic indicators of abuse, trauma informed interviewing considerations, and effective investigative action steps when working with vulnerable victims.
